Now on this 17th day of December, 1930, it being the regular November, 1930, Term of the District Court aforesaid and later than noon of the second day thereof, the aboveentitled cause comes on for hearing in its order and the plaintiff appearing in person and by his attorney, Hugh P. Finerty, and the defendant having been duly and legally served with an original notice in time for said term of court, and having filed her answer in said cause and although having been duly and legally notified of the hearing in said cause, appears not, neither personally nor by her attorneys and makes no defense in said action, the defendant is in default, and the Court having heard the testimony of the plaintiff and his witnesses and being fully advised in the premises, it is found:

That the equities in said cause are with the plaintiff; that the allegations contained in plaintiff's petition and in his amended and substituted petition and his amendment to petition and amendment to amended and substituted petition are true and that the plaintiff is entitled to a divorce from the defendant on the grounds of desertion and adultery; it is further found that the defendant is entitled to be the absolute owner of all of the interest of the defendant in and to Lot 10 in Block 3, Babbitt's Addition to the City of Council Bluffs, Iowa.

It is therefore ORDERED, ADJUDGED and DECREED that the bonds of matrimony heretofore existing between the plaintiff, Chris R. Thompson and the defendant, Dorothea F. Thompson, be, and the same are hereby wholly dissolved and the parties freed from the obligations thereof except the right to remarry for a period of one year; that the plaintiff, Chris R. Thompson, be, and he is hereby awarded the absolute title to Lot 10 in Block 3, Babbitt's Addition to the City of Council Bluffs, and the title thereto is hereby quited in him as against any claim or right of the
