I hereby certify that the title to the real estate hereinafter described, has been changed and established in (1).....

of Edith Green during her natural life or until she marries.  
and in accordance with the provisions of Section 10836, Code of 1927, you are therefore authorized, on payment of a  
transfer fee of twenty-five cents, to enter the same upon the transfer books as provided for in the transfer of deeds.

The description of the real estate hereinabove referred to, is as follows:

- (2) Lot Four (4) and the Westerly five feet of Lot Three (3) in Auditor's  
Subdivision of Lots Eighteen (18) and Nineteen (19) in Purples Subdiv-  
ision, an addition to the city of Council Bluffs, Iowa, known as  
#234 High School Avenue,

in Pottawattamie County, Iowa.

The change of title to the above described real estate was made as follows: By the last will of Hannah  
Green deceased which was admitted to probate by the District Court of Pottawatt-  
amie County, Iowa on December 22, 1931; paragraph second of which reads as  
follows: "I give, devise and bequeath unto my daughter Edith Greene of Council  
Bluffs, Iowa, the use, income, rents and profits of all of my estate of every  
kind and nature, real personal and mixed, and wherever situated during her natur-  
al life time or until she shall marry."

Paragraph Third of which reads as follows: "If my daughter Edith Green  
shall marry then my said estate shall be divided wqually among my children,  
George Clark Greene now of Berkley, California; Robert Bertram Greene now of  
Council Bluffs, Iowa; Thomas Gordon Greene of Sioux Falls, SouthDakota; Gertrude  
Children now of Pottawattamie County, Iowa; Jessie Elliott now of Whiting, Iowa;  
Edith Greene now of Council Bluffs, Iowa; Dorothy Stuart now of Council Bluffs,  
Iowa; Helen Carter now of Omaha, Nebraska; and Richard Cliff Greene now of  
Council Bluffs, Iowa.
