On this 30th day of September, 1947, this cause coming on for further hearing upon the report of the referees herein filed, the plaintiffs appearing by their attorney, G. C. Wyland, the defendant Marguerite C. Meyer appearing in person and the minor defendants Lucille Meyer and Delmar Meyer appearing by Oscar H. Rock appointed Guardian ad litem for them, the matter proceeds to trial.

The court finds that the referees have allotted to Edwin Ferdinand Meyer the west half of Northeast quarter of Section 22; Southeast quarter of Northwest quarter of Section 34; Township 76, Range 40, all in Pottawattamie County, Iowa; and that they have allotted to the widow and devisees of Walter Meyer, deceased, the East half of Southwest quarter and Southwest quarter of Southeast quarter, Section 15, Township 76, Range 40, in Pottawattamie County, Iowa, with the recommendation that Edwin Ferdinand Meyer be paid \$3500.00 by the other parties.

The court further finds that Marguerite C. Meyer has paid Edwin Ferdinand Meyer the sum of \$3500.00 from her individual means and that no lien need be placed upon the land therefor.

It is therefore ordered, adjudged and decreed that Edwin Ferdinand Meyer is the absolute owner of the real estate hereinbefore described and set off to him; and that the other parties are the absolute owners of the real estate hereinbefore described set off to them, they to hold the same pursuant to the terms of

the will of Walter Meyer, deceased; and the report of the referees is confirmed in all respects.

It is further ordered that the referees allowed the sum of \$30.00 for their services; that G. C. Wyland be allowed the sum of \$250.00 for his services; that Edwin Ferdinand Meyer pay one half of said fees and one half of all court costs herein and that Marguerite C. Meyer pay the other one half of said fees and costs.
