

REPORT OF CHANGE OF TITLE, made by Decree of Court or by Will.

Range 43, More particularly described as follows: Commencing at the North-west corner of said Lot One (1) and running thence South 6.14 chains, thence East 12.92 chains to West line of Lot 2 in said Subdivision, thence North 3.22 chains to Northwest corner of said Lot 2, thence East 7.08 chains to East line of said Southeast Quarter of the Southwest Quarter, thence North 2.92 chains to Northeast corner of said Southeast Quarter of the Southwest Quarter, thence West 6.08 chains to place of beginning, together with the highway and road and road now being used upon said tract of land and the main highway to the West as the same is now and has always been traveled and used, ~~in Pottawattamie County, Iowa~~ and the title of the plaintiff as to said described real estate is established, quieted and confirmed as against the defendant.
