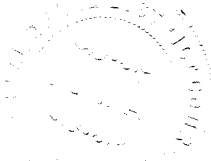
To the County Auditor of Pottawattamie County, Iowa:

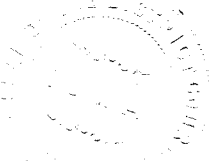
