Section 606-14. Where the title of any real estate is transferred by deed, mortgage, judgment, decree, or where title to real estate is changed by any other means, the auditor of the county, at the time of recording the same, shall, in addition to the seal of said court, to the county auditor or the county clerk, place on the record a statement of the title to the land which said land is located.
