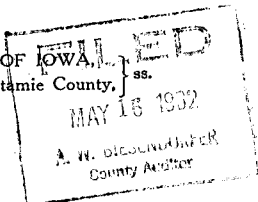

The description of the real estate hereinabove referred to, is as follows:

- (2) West 82½ feet of Lot 5, Bigelow's Addition, Town of Walnut; also part of Lot 3 Auditor's sub-division of SW¼ SW¼, except Bigelow's Addition to Walnut, in Section 9 in Township 77 N, Range No. 38 West of the 5th P. M., being more particularly described as follows, to-wit: Commencing at a point 36 rods North and 40 rods West of the SE corner of said SW¼ SW¼, Section 9, Township 77, Range 38, running thence North 42 rods 8 feet, thence East 20 rods, thence South 142 feet, thence West 5 rods to NW corner of Lot 3 in Bigelow's Addition to Walnut, thence South 313½ feet to SW corner of Lot 5 in said Bigelow's Addition, thence East 5 rods to SE corner of angle of said Lot 5 Bigelow's Addition, thence North 5 rods to intersect South line of Lot 6 in said Bigelow's Addition, thence East 216½ feet, thence South 5 rods, thence West 6 rods, 5 feet, thence South 13 rods and thence West 28 rods to place of beginning
