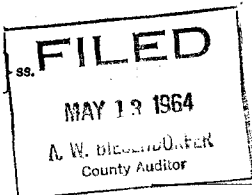

To the County Auditor of Pottawattamie County, Iowa:

I hereby certify that the title to the real estate hereinafter described, has been changed and established in (1) Maine M. Larsen and in accordance with the provision of Section 333.15, Code of 1954, you are therefore authorized, on payment of transfer fee of fifty cents, to enter the same upon the transfer books as provided for in the transfer of deeds.

The description of the real estate hereinabove referred to, is as follows:

(2) The Southeast Quarter and the South Half of the Northeast Quarter of Section 2, Township 77, Range 38 West of the 5th P.M. in Pottawattamie County, Iowa, and, all of the South 8 rods of the North Half of Northwest Quarter of Northeast Quarter of Southwest Quarter of Section 9, Township 77, Range 38 in Walnut, Pottawattamie County, Iowa, except that part described as beginning at the Southeast Corner of the North One Half of the Northwest Quarter of Northeast Quarter of Southwest Quarter of said Section 9, thence West 310 feet, thence North 132 feet, thence East 310 feet, thence South 132 feet to place of beginning, and, The North Half of the Northeast Quarter of Section 2, Township 77, Range 38 West of the 5th P.M. in Pottawattamie County, Iowa, and Lots 5 and 6 in Block 1 of Whitney, Crawford and Merriman's Addition in Pottawattamie County, Iowa, to the Original Town of Walnut, Iowa

The change of title to the above described real estate was made as follows:

(3) By WILL of G. Dewey Larsen in which he says "I give and bequeath all property of every kind unto my wife, Maine M. Larsen, and appoint her Executrix without bond" and by Order of Court filed May 11, 1964, and signed by the Honorable Leroy H. Johnson, Judge of the 15th Judicial District, which states in part "It is further ordered that the Clerk issue a certificate of change of title of all real estate listed herein to Maine M. Larsen and that the Clerk of Court send said certificates of change of title to the County Auditors of the Counties in which the land herein is located."
