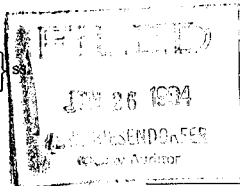

REPORT OF CHANGE OF TITLE, made by Decree of Court or by Will.

To the County Auditor of Pottawattamie County, Iowa:

I hereby certify that the title to the real estate hereinafter described, has been changed and established in (1) Roberta J. Mains, Adult 21 years 17 years and in accordance with the provision of Section 333.15, Code of 1954, you are therefore authorized, on payment of transfer fee of fifty cents, to enter the same upon the transfer books as provided for in the transfer of deeds.

The description of the real estate hereinabove referred to, is as follows:

(2) Lot 5, Block 9, Town of Oakland, Iowa

in Pottawattamie County, Iowa.

The change of title to the above described real estate was made as follows:

(3) By the Will of Anna L. Penniston, decedent, which states "I hereby devise and bequeath all of my property and estate, real, personal and mixed, as follows, at and after my death:
One-half thereof to my daughter, Roberta J. Mains of Des Moines, Iowa, or if she be not living, to her children in equal shares, share and share alike, and One-half thereof to the children of my deceased daughter, Thelma Cochran, to be theirs in equal shares, share and share alike, subject however, to the terms and conditions of the trust provisions outlined in the following paragraph of this my Last Will and Testament.
At the time of my death, in the event the children of Thelma Cochran, or any of them, are under the age of twenty-one years, it is my will that said minor child or children's share of my estate be and the same is hereby devised and bequeathed to my son-in-law, Clayton L. Cochran, father of said children, residing now at 34 East Jackson Road, St. Louis, Missouri, but in trust and as trustee nevertheless, for the following uses and purposes, to wit:
- - - Said trust is to terminate as to each of said children, when he reaches the age of 21 years.
