

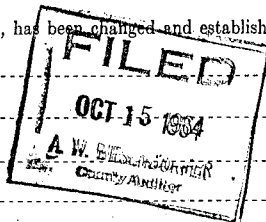

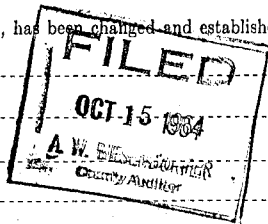

Where a person or persons by judgment or decree of said court or of the supreme court, or where title to real estate is transferred by deed, or where the proceeds of a sale or order in probate, the clerk of the district court shall certify the same, under the seal of said court, to the auditor of the county in which said land is located.
