The change of title to the above described real estate was made as follows:

(3) By will dated March 31, 1931 and by Order of Court dated June 29, 1965.

The will states: "Par. IV. Subject to the provisions before made for my husband, I give, devise and bequeath all of my property of every kind and character unto my three children, Harry Holst, Walter Holst and Elmer Holst, share and share alike, the same to be theirs absolutely." And the Order states: It is further Ordered that the Clerk of the District Court issue a certificate of change of title to all real estate owned by the decedent as described in the Final Report showing title to said real estate one third in Walter Holst, one third in Elmer Holst, one sixth in Gaylan H. Holst and one sixth in Sherry Koch and file said certificat with the Pottawattamie County Auditor. " Signed by Hon Leroy H. Johnson, Judge of 15th Judicial District. (-Gaylan Holst and Sherry Koch are issue of Harry Holst who predeceased his mother, Anna Holst.)
