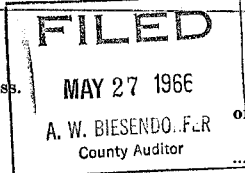

The description of the real estate hereinabove referred to, is as follows:

Parcel #1

The East two rods of the SE $\frac{1}{4}$  of the SW $\frac{1}{4}$ ; and the NE $\frac{1}{4}$  of the SW $\frac{1}{4}$ , except a tract described as follows: Commencing at the Southwest corner of said 40 acre tract, running thence North 33 rods, thence Southeasterly 43 rods, thence West 26 rods to place of beginning, all in Section One (1), Township 76, North, Range 44, West of the 5th P. M.

Parcel #2

SE $\frac{1}{4}$  NW $\frac{1}{4}$ ; that part of SW $\frac{1}{4}$  NE $\frac{1}{4}$  described as follows: Beginning at the Southwest corner of the SW $\frac{1}{4}$  NE $\frac{1}{4}$  running thence north 20 chains, thence east 7.2 chains, thence South 35° east 7.50 chains, thence south 38 $\frac{1}{2}$ ° east 13.92 chains to east line of said 40 acre tract, thence south 3.7 chains to southeast corner of said 40 acre tract, thence west 20 chains to place of beginning, except that part lying north and east of the public road as now established; that part of NE $\frac{1}{4}$  SE $\frac{1}{4}$  described as follows: Beginning at the NW $\frac{1}{4}$  corner of said NE $\frac{1}{4}$  SE $\frac{1}{4}$  running thence east 2.70 chains, thence south 45 $\frac{1}{4}$ ° east 4.3 chains, thence south 60 $\frac{1}{2}$ ° east 2.85 chains, thence south 1° west 11.50 chains, thence south 62 $\frac{1}{2}$ ° west 8.75 chains to southwest corner of said 40 acre tract, thence north 26 chains to place of beginning; NW $\frac{1}{4}$  SE $\frac{1}{4}$  except what is known as McIntosh cemetery, said cemetery containing 1 $\frac{1}{2}$  acres and is described as follows: Beginning at the southeast corner of said NW $\frac{1}{4}$  SE $\frac{1}{4}$  running thence west 43 rods, thence north 12 rods, thence east 15 rods, thence south 10 rods, thence east 28 rods, thence south 2 rods to place of beginning, all being in Section One (1) Township 76, Range 44, subject to the right of the public in all highways and roads as now established.

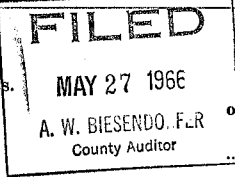
