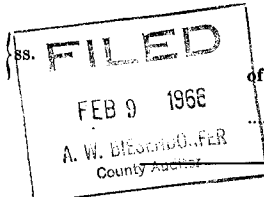


REPORT OF CHANGE OF TITLE, made by Decree of Court or by Will.
