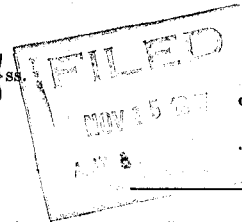

A fractional part of NE $\frac{1}{4}$ NE $\frac{1}{4}$ Section 8, Township 74, Range 43, described as follows: Beginning at the intersection of the East line of said Section 8, and the Southerly right of way line of the State Highway, thence Westerly along the Southerly right of way line of said Highway a distance of 153 feet to place of beginning, thence Southerly a distance of 428 feet, thence Southwesterly a distance of 226.5 feet, thence Northwesterly a distance of 206 feet, thence Northerly a distance of 403 feet to the Southerly right of way line of said State Highway, thence Easterly along the Southerly right of way line of said Highway a distance of 370 feet to place of beginning and containing 3.89 acres, more or less, situated in Pottawattamie County, Iowa; and *NE NE 8-74-43 NW NW 9-74-43*

A fractional part of Sections 8 and 9, Township 74, Range 43, Pottawattamie County, Iowa, described as follows: Commencing at the intersection of the East line of Section 8 and the Southerly right of way line of Highway 92, thence Westerly along the Southerly line of said Highway 92, a distance of 153 feet to a place of beginning; thence Southerly at a 90° angle 428 feet; thence in a Southeasterly direction 131 feet to a metal marker; thence Northeasterly 710 feet to a point on the Southern right of way of Highway 92 that is 627 feet East of place of beginning; thence West along Southerly right of way of Highway 92 to place of beginning, containing 4 acres more or less; said land adjoining to the East the land purchased by second party from Roger E. and Shirley J. Rasmussen, which deed is recorded in Book 1240, Page 549, Records in the office of County Recorder of Pottawattamie County, Iowa.

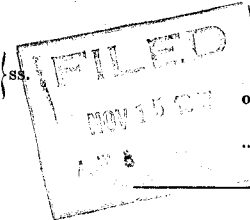
