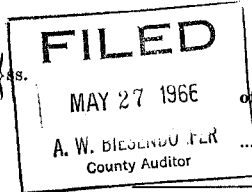

Commencing at a point 27.40 chains North and 50 links West from Southeast corner of $W\frac{1}{2}$ SE $\frac{1}{4}$ said Section 24, and running thence North 30 rods, thence West 32 rods, thence South 30 rods, thence East 32 rods to place of beginning, and also known as Lot 1, Auditor's Subdivision of $NW\frac{1}{4}$ NE $\frac{1}{4}$ of said Section 24, excepting that part of said premises conveyed by Warranty Deed to George H. and Betty J. 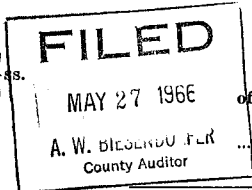
