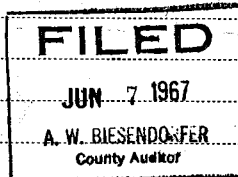

Where the title of any real estate is finally established in any person in part or in whole by judgment or decree of a court, the real estate is changed by judgment decree, will, proceeding or order in probate, the clerk of the district court shall certify the same, under the seal of said court, to the county auditor of the county which said land is located.
