Where the title of any real estate is finally established in any person or persons by a final judgment of the supreme court of the state, or where title to real estate is obtained by judgment, decree, will, proceeding, or order in probate, the auditor shall, upon receipt of a certified copy of the judgment, decree, will, proceeding, or order in probate, the seal of said court, to the county auditor of the county in which said land is located.
