Section 8834. Change in Title.—Certification. Where the auditor of a county certifies that a change of title or persons by judgment or decree of said court or of the supreme court, or where title to real estate is changed by judgment or decree of said court, and the same is duly filed of record, with appropriate fees, in the office of the clerk of the district court shall certify the same, under the seal of said court, to the county auditor of the county in which said land is located.
