Section 896.14. Change in Title - Certificate. Where the title of any real estate is finally established in any person or person by judgment or decree of court or of the Auditor, the Auditor shall, upon application of the Auditor, decree, with, proceeding, or order in public, the clerk of the district court shall certify the same, under the seal of the court, to the Auditor, and the Auditor shall issue a certificate of title to the owner of the same, which said land is located.
