Section 686.14. Change of Title - Certificates. - Where the title of any real estate is finally established in any person by judgment, decree, or order of a court of record, or by judgment, decree, will, proceeding, or order in probate, by the court having jurisdiction thereof, the county auditor, by seal of said county, shall certify the same, under the hand of said auditor, and the county auditor of the county in which said land is located.
