Section 606.14. Change in Title—Certification. Where the title of any land is changed in any manner, whether by deed, mortgage, judgment or decree of the supreme court, or where title to real estate is changed by judgment of the district court, the auditor of the county in which the land is located shall certify the same, under the seal of said county, to the county auditor of the county in which said land is located.
