Where the title of any real estate is finally established in any person or persons by judgment or decree of said court, or of the county auditor, and the same is duly recorded, the county auditor, clerks, with, possessing, or order in possession, the title of the district court shall certify the same under the seal of said court to the county auditor of the county in which said land is located.
