Section 661.4. Change in Title - Certification. Where the title of any real estate is finally established in any person or persons by a final judgment, decree, or order of a court of competent jurisdiction, or where title to real estate is changed by judgment, decree, will, proceeding, or order in probate, the auditor shall certify to the county auditor the date of the judgment, decree, will, proceeding, or order, and the date of the seal of said court, to the county auditor of the county in which said land is located.
