Section 606.14. Change in Title - Certification. Where the title of any real estate is finally established in any person or persons, by judgment or decree of said court or of the supreme court, to whom the same is referred, and entered in the judgment, decree, will, proceeding or order in probate, the seal of said court or courts shall certify the same, under the seal of said court or courts, to the county auditor of the county in which said land is located.
