Section 56614. Change in Title.—Confirmation. Where the title of any real estate is finally established in any proceeding, and the same is confirmed by the court, or of the judgment, decree, will, proceeding, or other legal proceeding of the district court shall certify the same, under the seal of the court, to the county auditor of the county in which said land is located.
