Section 6614. Change in Title - Certification. Where the title of any real estate is finally established in any person or persons by judgment or decree of a court of competent jurisdiction, or by deed, will, power of sale, or otherwise, and the same is changed by judgment, decree, will, power of sale, or otherwise, the clerk of the district court shall certify to the county auditor the date of the change, and the county auditor shall enter the same in the records of the county in which said land is located.
