1. All that part of the NE-1/4 SW-1/4 and the north 15 acres of the SE-1/4 SW-1/4 of Section 35, Township 76, Range 44 lying south and west of the Lime Kiln Road except private driveway contained along the west side of the east line of said SE-1/4 SW-1/4 of Section 35, Township 76, Range 44. (Home place - approximately 37 acres).

2. Lot 1, Auditor's Subdivision of the NW-1/4 NW-1/4 of Section 35, Township 76, Range 44, described as beginning at the Northeast corner of said NW-1/4 NW-1/4 of said Section 35, running thence West 394 feet; thence South 1109 feet; thence East 394 feet; thence North 1109 feet to place of beginning, containing in all ten (10) acres.

3. Section 606.14. Change in Title.—Certification. Where the title of any real estate is finally established in any person or persons by judgment or decree of said court or of the Supreme Court of Iowa, and the same is duly recorded in the records of said court, the clerk of said court, upon the request of the owner or owners of the same, shall certify the same, under the seal of the district court, shall certify the same, under the seal of the district court, to the county auditor of the county in which said land is located.
