Section 66.14. Change in Title - Certification. Where the title of any real estate is finally established in any person or persons by a judgment, decree, or order of a court of competent jurisdiction, or where title to real estate is conveyed by a deed or other instrument, the county auditor, upon the receipt of a certified copy of such judgment, decree, or order, or of such deed or other instrument, shall cause the title to be changed in the records of said court, to the county auditor of the county in which said land is located.
