Section 606.14. Change in Title—Certification. Where the title of any real estate is finally established in any person, partnership, corporation, or other legal entity, and the same is duly recorded in the public records of the county, the auditor, before recording the same, shall ascertain, by judgment, decree, will, proceeding, or order in probate, the person, partnership, corporation, or other legal entity, to whom the title of said estate is changed by the person, partnership, corporation, or other legal entity, the seal of said county, to the county auditor of the county in which said land is located.
