Section 69314. Change in Title.—Certification. Where the title of any real estate is finally established in any person or persons by judgment or decree, or where the title of any real estate is changed by judgment or decree, will, proceeding, or order in probate, the clerk of the district court shall certify and file in the records of the district court the name of the person or persons to whom the title of the land is located.
