Section 606.14. Change in Title.—Certificate. When the title of any real estate is finally established in any person or persons by judgment or decree of said court or of the judgment, decree, will, proceeding or order in relation to the estate of a decedent, or in relation to the estate of a testator, the clerk of the district court shall certify the same, under the seal of said court, to the county auditor of the county in which said land is located.
