Section 8614. Change in Title.—Certification. Where the auditor of a county is duly qualified, any person or persons by judgment or decree of said court or of the supreme court, or where title to real estate is changed by judgment or decree of said court, or where the title to the land of the district court shall certify the same, under the seal of said court, to the county auditor of the county in which said land is located.
