Section 602.14. Change in Title — Certification. Where the title of any real estate is changed by judgment or decree of a court of competent jurisdiction, or where title to real estate is transferred by judgment, decree, or order of a court of competent jurisdiction, the auditor of the district court shall file, or enter in public, the name of the person to whom the title is transferred, the date of the transfer, and the name of the county and the name of the person to whom the title is transferred.
