Section 606.14. Change in Title.—Certification. Where the title to real estate is changed by the sale of the same or persons by judgment or decree of the supreme court, or where title to real estate is changed by the operation of law, the auditor of the county in which the change of title occurs shall certify the same, under the seal of said court, to the county auditor of the county in which said land is located.
