Section 53614. Change in Title - Certification. Where the title or any part of the same is transferred by deed or otherwise to any person, or where title is changed by judgment, decree, or otherwise, the auditor of the county in which said land is located shall certify the same under the seal of said county, to the county auditor of the county in which said land is located.
