Section 906.14. Change in Title.—Certification. Where the title of any real estate is finally and properly transferred to any person by any instrument recorded in the county auditor's office, or where title to real estate is obtained by judgment, decree, order, or other legal proceeding, the auditor shall certify the same under the seal of said county, to the county auditor of the county in which said land is located.
