Section 0614. Change in Title - Certification. Where the title of any real estate is finally established in any person or persons by a final judgment of the supreme court, or where title to real estate is changed by judgment, decree, will, proceedings or order in probate, the auditor, after receiving notice of such proceedings, shall seal of said court, to the county auditor of the county in which said land is located.
