Section 686, 14. Change in Title.—Certification. Where the title of any real estate is finally established in any person or persons, or in any corporation, or in any partnership, or in any trust, or in any other person or persons, by the judgment, decree, will, proceeding, or order in probate, the seal of said court, or the seal of the county in which said land is located, shall be placed on the copy of said court record, and the same shall be filed in the office of the auditor of the county in which said land is located.
