Section 6624. Change in Title.—Certification. Where the title of any real estate, or any interest therein, or persons by judgment or decree of said court or of the court of appeals, or by any other authority, is changed by judgment, decree, or otherwise, and the same is changed by the clerk of the district court, or by the clerk of the court of appeals, or by the clerk of the district court, or by the clerk of the court of appeals, the county auditor of the county in which said land is located shall certify the same, under the seal of his office, to the county auditor of the county in which said land is located.
