Sec. 603.14. Change in Title Certification. Where the title of any real estate is freely granted in any court of competent jurisdiction, and the title in court or of the supreme court, or where title to real estate is changed by judgment, decree, will, proceed- ing, or otherwise, the auditor of the county in which the land is located shall certify the same, under the seal of said court, to the county auditor of the county in which said land is located.
