Section 936.14. Change in Title. Certification. Where the title of any real estate is finally established in any person or persons by a judgment or decree of the district court or by a deed, or where the same is established by a deed, and the same is changed by judgment, decree, will, proceeding, or order in any court of law, or by any other authority, the clerk of the district court shall certify the same, and file the same in the office of the county auditor of the county in which said land is located.
