Section 905.14. Change in Title. — Certification. When the title of any real estate is finally established in any person or persons by a judgment or decree of the district court or by a deed, or when the title of any real estate is finally established in any person or persons by a judgment or decree of the district court or by a deed, the clerk of the district court shall certify the same, in proper form, to the county auditor. The county auditor shall, in proper form, certify the same to the county in which said land is located.
