Where the title to real estate is finally established in any person or persons by a judgment or decree of the district court or by a decision of the department of revenue, the same shall be subject to taxation as if the title had been so established. In any proceeding or order in a proceeding, the clerk of the district court shall certify the same under the seal of said court to the county auditor of the county in which said land is located.
