Section 628.14. Change in Title - Certification. Where the title to any real estate is finally established in any person or persons by a judgment or decree of the district court or otherwise, the auditor shall certify the same to the county auditor. In any event, decree, will, proceeding, or order in a probate case, the clerk of the district court shall certify the same to the county auditor. The county auditor shall certify the same to the county in which said land is located.
