Section 663.14. Change in Title - Certification. Where the title of any real estate is finally established in any person or persons by a judgment or decree, or where the title to said estate is determined by a judgment or decree, or where the title to said estate is changed by judgment, decree, will, proceeding, or order in probate, the clerk of the court to which such judgment, decree, will, proceeding, or order is made shall cause to be filed in the county auditor of the county in which said land is located.
