Section 624. Change in Title - Certification. Where the title of any real estate is finally established in any person or persons by a judgment or decree of the district court, either in favor of or against the person or persons whose title is so established, the title of such real estate shall be changed by judgment, decree, will, proceeding, or order in probate, the clerk of the district court shall certify the same to the auditor of the county in which said land is located.
