Section 607.14. Change in Title.—Certification. Where the title of any real estate is changed by deed, mortgage or persons by judgment or decree of said court or of the judgment, contract, or other title to real estate is changed by the court, the auditor of the county, or the auditor of the clerk of the district court shall certify the same, under the seal of the court, to the county auditor of the county in which said land is situated.
