Where the title of any real estate is finally established in any person or persons by a judgment or decree of the district court or by a deed or other instrument of record, and the title is thereafter changed by judgment, decree, will, proceeding, or other instrument, the clerk of the district court shall certify to the county auditor the date of such change and the county in which said land is located.
