When the title of any real estate owned by any person or persons is changed by a judgment or decree of the district court or by a decision of an appellate court, or where title to real estate is changed by any other legal proceeding, the auditor of the county in which the land is located shall certify the same, under the seal of said court, to the county auditor of the county in which said land is located.
