Section 6614. Change in Title. - Certification. Where the title or any real estate or liability of the district court or by a decision of an appellate court, or where title to real estate is changed by judgment, decree, court order, or final order of any court, the county auditor shall certify the same under the seal of said court, to the county auditor of the county in which said land is located.
